Subject: Payment and Refund Policy

Welcome! As a member of the Far East Council's 2020 Philmont Expedition you are about to embark on an adventure that you will remember for a lifetime. **The council has been awarded a 12-Day Expedition, 16-28 July 2020. The total amount of participants is set at 20 (youth and adults).** Registering your interest for the Trek can be done by visiting The Expedition payment schedule is outlined below. Payments must be made at the council stores by the dates indicated. <u>Any Expedition member registering after any of the below dates will be responsible for making all payments that were due prior.</u>

1st payment = \$100 per person – due 15 April 2019
2nd payment = \$462.50 per person – due 15 September 2019
3rd payment = \$462.50 per person – due 1 February 2020
4th payment = Only if determined by the Expedition leadership as needed to cover the cost of Expedition items, hotel, and transportation expenses.

The Philmont Refund Policy states "All fees are non-refundable, nor may they be applied to the balance of fees if the size of the Expedition is reduced". If an individual has signed up to attend and then finds he or she cannot attend, a refund may be processed by the local council only if they have a replacement Expedition member. Individual refund requests should be submitted to the council staff advisor.

The Council started the planning process in 2018 by signing a legal agreement that requires non-refundable installment payments to Philmont by specific dates. Once a person commits to the council Expedition they have locked out that position to other potential applicants. No refunds will be given unless a replacement for that specific position is found. New applicants are not considered replacements until the Expedition is full.

The council and Expedition leaders will attempt to remind Expedition members when payments are coming due; but it is the responsibility of the individual to ensure payments are made by the due dates unless other arrangements are made with the council coordinator. Failure to make scheduled payments could result in the slot be forfeited.

Your Expedition Leader will be identified in the near future and will be your first point of contact for questions. Again, welcome to the Far East Council's 2020 Philmont Expedition! You are in for an adventure of a lifetime!
